We have reviewed the final revisions to the Suggested State Regulations (SSR) Part C, "Licensing of Radioactive Material" received by our office on March 25, 2010 for federal concurrence. These regulations were reviewed by comparison to the equivalent Nuclear Regulatory Commission (NRC) rules in 10 CFR Parts 30, 31, 32, 40, and 70. We discussed our review of the regulations with Sue Smith on May 5, 2010.

As a result of our review, we have no comments and concur on Part C. Please note that we have limited our review to regulations required for compatibility and/or health and safety. We have determined that the regulations, as adopted, meet the compatibility and health and safety categories established in the Office of Federal and State Materials and Environmental Management Programs (FSME) Procedure [SA-200](#).
